JOHN FLEMING TO CONDUCT THE 1ST WBA – IBC SUPERVISORS, TECHNICAL OFFICIALS AND RINGSIDE DOCTORS SEMINAR AT NEW DELHI FROM FEBRUARY 17TH TO FEBRUARY 19TH 2016.

The Indian Boxing Council, today announced the conduct of a Technical officials Seminar by WBA Technical delegates. The seminar is aimed at equipping Indian officials to officiate at National, Asian & World level Pro Boxing contests. The IBC is affiliated to the World Boxing Association, headquartered in Panama City, South America. The WBA founded in 1921 is the oldest amongst the 4 largest organizations which sanction world championship boxing bouts.

The 3 day seminar organized by the Indian Boxing Council will be held in a hotel in the city from 17th to 19th Feb 2016. The international officials for the seminar were nominated by the President, World Boxing Association Mr. Gilberto Jesus Mendoza during the 94th WBA Convention at Panama City.

Stanley Christodoulou, Advisor – WBA, Regional development is one of the most recognized faces in Pro Boxing around the world and was inducted into the International Boxing Hall of Fame in Canastota, New York on 13 June 2004. He was the first man to referee world title fights in all 17 weight categories, and the third to oversee 100 world title bouts. Christodoulou served as executive director of the South African Boxing Board of Control, and has twice been named South Africa Boxing's 'Man of the Year'.
